EMBYRO TRANSFER CONTRACT INFORMATION 2024

This contract undertaken on ____ / ____ / 2024/25 between client_____ and West Coast Veterinary Hospital. West Coast Veterinary Hospital are responsible for the process undertaken in breeding, embryo transfer retrieval, transfer and agistment of recipients mare till 45 days. Donor mare name_____

West Coast Veterinary Hospital offer two contract options;

Option A: Recipient synchronisation and embryo flush procedure fee: \$1150, Embryo wash/transfer procedure (only payable if embryo retrieved) \$395 Pregnancy success fee: \$2500 this covers management of recipient mare at West Coast Vets through to 45 day scan and lease of mare until weaning. This is payable at 45 positive scan.

Option B:

All inclusive contract. During the breeding season of 2024, the mare owner is entitled to 3 attempts to have an embryo/s recovered from donor. **The all inclusive contact is \$2950 with an additional fee of \$1000 that is a recipient mare guarantee fee. Upon signing the contract \$3950 will be payable prior to reproductive work taken out.**

On positive 45 day scan the recipient success mare fee applies at \$2500 for lease of the mare until weaning. The owner is responsible for and agrees to pay for any and all vet expenses of the recipient mare after 45 days. The owner shall return recipient mare in good health within 6 months of the foaling date.

Upon signing this contract mare owner will be invoiced \$1000 for the recipient mare guarantee fee plus 50% off the contract fee off \$3950 totalling \$2975. The recipient fee ensures a suitable mare that is reproductively sound will be synchronised with the donor mares cycle. This covers the fees involved in reproductive management, agistment, feeding etc and all care till embryo is 45 days mature. Also included are all exams up until transfer is undertaken. This fee is non transferable to another donor mare and is valid until March 2025 for the above mare. This fee of \$1000 is only payable once regardless of how many embryos are flushed and transferred.

Recipient mare lease fee off \$2500 is payable upon 45 day positive scan. If more than one embryo is retrieved and transferred successfully the mare lease fee is payable per mare. The owner is responsible for all expenses of the mare after 45 days gestation. Each mare is to be returned to West Coast Veterinary Hospital within 6 months of foaling date. Mares must be returned in good health, wormed and recently trimmed.

West Coast Vets suggests insurance to be taken out over recipient mare and embryo against all losses and risks of any kind, nature and description. Owner holds West Coast Vets harmless with respect to said loss and risks.

Mare owners understand that there are many factors involved in breeding mares, recovery of embryo/embryos, implantation and although West Coast Vets honours its best efforts to honour services mentioned but no guarantee for the success of the procedure.

If by March 2025 no successful embryo is flushed and transferred the contract is deemed terminated. Remaining fees are to be paid minus the recipient mare fee. West Coast Vets hold the right to refuse services if accounts are overdue.

All fees are to be paid prior to release of recipient mare. Three days notice must be given before mares are to be released so paperwork can be completed. Transportation expenses are owners responsibility.

AGISTMENT

West Coast Vets offer limited agistment at 10 Freeman Rd Forrestdale with safe large sand mare and foal yards with summer misters and horseshoe safe paddocks for foaling down. Mare owners can choose whether to have their mares in a yard or paddock. We feed high quality feed including Hygain Ice and Hygain Tru Breed, with choice of meadow/lucerne or oaten hay. Mare diet forms will be completed when mares are dropped off.

Agistment rates are Stallions \$45 per day Dry Mare \$30 per day and Wet Mare \$40

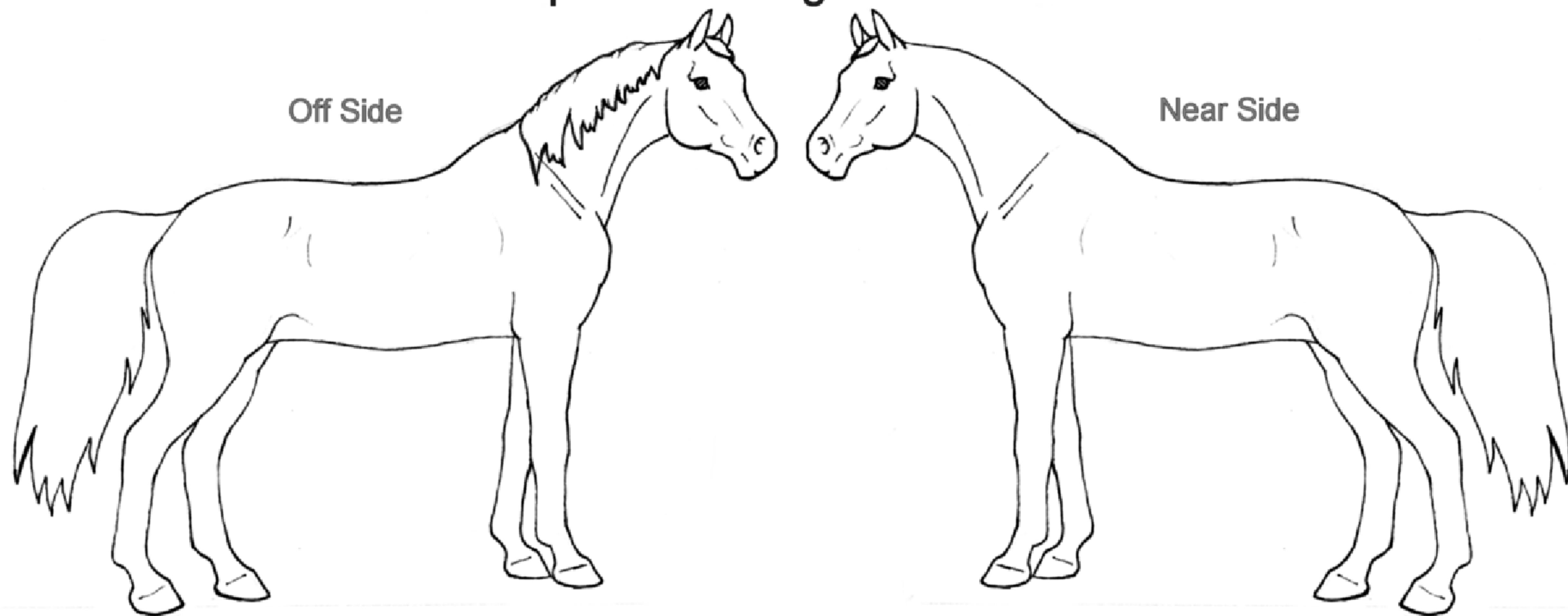
